RESOLUTION 19-007

A RESOLUTION THAT CANCELS THE LEWISTON CITY NOVEMBER 5, 2019 MUNICIPAL ELECTION AND CERTIFIES THAT THE NUMBER OF CANDIDATES DOES NOT EXCEED THE NUMBER OF OPEN AT-LARGE MUNICIPAL OFFICES.

WHEREAS, the Lewiston City Council desires to cancel the November 5, 2019 Municipal Election and certifies that the number of candidates does not exceed the number of open at-large municipal offices;

- Pursuant to Utah Code 20A-1-206: A municipal legislative body may cancel an election if: all the candidates, including any eligible write-in candidates have filed.
- Lewiston City has three at-large council seats open for election;
- The City Recorder received three declarations of candidacy; three (3) for council seats- Kim (Fizz) Bodily, Jonna Westover, Debbie Wright.
- Lewiston City has no municipal ballot propositions.
- Lewiston City did not receive any write-in candidates.
- Lewiston City now has three candidates for three at-large council seats.

Therefore be it resolved by the Lewiston City Council:

- The Lewiston City November 5, 2019 election is hereby cancelled.
- The Lewiston City Council certifies there are three at-large (3) council seats, and there are no municipal ballot propositions.
- The following candidates are considered to be elected to office: Kim (Fizz) Bodily, Jonna Westover, Debbie Wright.
- This resolution shall become effective immediately upon passage.
